


Figure 1- Port Louis Grenada

	Established in 1994, YSATT is a non-profit organization that aims to ensure the continued and sustained growth of our yachting Services Industry. YSATT's members include most organizations that have an active interest in the yachting industry. We work with the Tourism Development Company to increase yacht arrivals by promoting Trinidad and Tobago as a yachting destination. We are the private sector organization that liaises with Customs and Immigration to facilitate foreign yachts. We work with the Coast Guard, the Police and the CDA Police to create a safe environment for visiting cruisers.
	How has being a member of TTCSI benefitted YSATT?
	The Trinidad and Tobago Coalition of Services Industries (TTCSI) is an umbrella, non government, business support organization, established to encourage the growth and development of the services sector. As such, being a member of TTCSI has benefitted YSATT's development in several ways including:
	- They, being a part of the services sector as us, stand together for issues facing our sector.
	 They help us reach out to various Ministries in resolving issues.
	- They are currently helping us to lobby for the safe reopening of our Industry.
	- They keep us informed about opportunities arising for the business community,
	 In this current covid environment they keep us informed about new protocols which are being implemented by the different sectors.
	 We look forward as a new member working with TTCSI as they help us in getting exemptions granted to our customers.
Γ	The Yachting industry remains closed due to the pandemic. YSATT has been actively lobbying for the re- opening of the industry, what measures has YSATT taken to ensure the safety of its members and visitors if the sector is able to re-open?
	YSATT has implemented a Port Health Safety System (PHSS) which has been approved by the Ministry of Health for the safe reopening of the sector to our customers the cruisers. We are still awaiting exemptions to be granted to them, however, in the interim the Ministry of Tourism has added to their overall plan for the safe reopening of the Tourism Sector, our approved PHSS protocols. The Ministry of Trade has been actively lobbying on our behalf with the Ministry of National Security and the Ministry of Health for this cause as well. Our PHSS will be our long term system for the safety of our customers and our members when yachts are allowed to enter our island. As we are continually informed through TTCSI of new requirements being implemented by the various Ministries we will continue to update our requirements and inform our members, our customers and the Yacht services community at large, through our website, our facebook page and other social media avenues thus ensuring current safety measures are always in place and that we are ready when the Government grants exemptions to yachts.
